• The website of the project MUST be improved as info and also design. Short description of the project objectives and impact in the section ABOUT. Full agenda of the activities (e.g. C1). The intellectual results and corresponding intermediary phases uploaded in the section OUTPUTS.

We agree that the website has to be redesigned in order to be more attractive. New suggestions from both partners will be welcome for performing the improvement. Bogdan Jurca (website responsible) will be contacted by Madalina and will perform the web modifications.

• Project info should be disseminated also by NTNU partner involving the post of the project info on the NTNU site. Project info must be more visible than now!

NTNU partner agreed to post the link of the project website on the faculty site. For dissemination of the project activities on the NTNU website, the corresponding info has to be provided in advanced with 1-2 weeks before the activity time.

3. Planning the project activity according with the project proposal in the actual context:

- first students' mobility (April 6th to May 5th 2021);

The partners agreed on the mobility date - April 6th to May 5th 2021.

second students' mobility (November 2021 or May 2022); May 2022 involves to prolong again the project period with 6 more months;

The period for the second students mobility was discussed. May 2022 is more convenient for NTNU partner. UB partner has to ask the agency for new prolongation of the project period (6 months more). New selection of students has to be performed for second stage of the students mobility.

- course module "Nanomaterials" (C2 activity - March 2021, Bucharest);

C2 activity will be developed as face-to-face (for the moment) on 22-26 of March 2021, Bucharest, Romania.

- workshop (11th – 15th October 2021, Bucharest);

special issue – June 2021 – June 2022;

The partners agreed on the period for the workshop - $11^{th} - 15^{th}$ October 2021, Bucharest. The discussion was focused on the SI because this has to be set up in advance (journal, invitation for submissions, title of SI, ...). Before the meeting. Catalysts journal was considered as an option. During the meeting, the conclusion was to lunch a question-request for Elsevier. The main reasons are the high fee of publication in the case of MDPI house and the missing section in the project budget for publications. Elisabeth will ask the Elsevier if they will agree to be the host for such a SI.

- next project meeting (May 2021, Trondheim);

The date proposed is 12th *of May 2021, Trondheim, Norway, just after the* summer school. One day project meeting with the participation of minimum 2 UB members and 4 NTNU members. (TPM4)

- video meeting (January/February 2021);

The next video meeting is proposed for the 29th of January (11:00 Romanian time/10:00 Norwegian time) for discussing the details of the C2 activity.

- preparation of annual repost (February 2021)

It was discussed what the first annual report should contain. NTNU partner will provide the financial repost with the used budget and also supported by the copy of the documents. UB partner will provide a detailed financial report supported by all the original doc for financial costs. The scientific report will be prepared together by the partners. More info about how the scientific report has to look should be requested from the agency in the next period before the end of the year.

4. Website – dissemination of project website on the partners website and as much as possible on the social media.
